2. The cost to abate lead paint should be included in each Offeror’s Lump Sum Price.
3. The Contractor will be required to work around the schedule of each awarded school to complete the Project. Space will be made available on a rolling basis. The Department will cover the cost to compensate the school building engineer for any after hours or weekend work.
