Rules of Use:

- Drop-off services are available only to District residents. All users must show a valid DC driver's license, REAL ID Non-Driver Identification Card, or two documents verifying residency. For example: real property tax bill or utility bill.
- All vehicle operators entering the station must possess a valid driver's license. Vehicles entering the transfer station must be registered with the appropriate authority and must be insured.
- Acceptable materials include trash, bulk items, recyclables and yard waste only. Yard waste is defined as bagged leaves; grass clippings; weeds; bulbs; twigs; pine cones; uprooted plants; and bundles of branches or limbs tied into four-foot lengths. Yard waste does not include stumps; dirt; stones; broken concrete; broken pottery flower pots; roofing material; or construction and/or demolition material.
- All waste materials must originate within the District of Columbia. Facility staff reserves the right to ask for proof of origin.
- Access is permitted for the following vehicles: passenger cars, passenger vans, SUVs, pick-up trucks and vans less than 14 feet in length. Rental vehicles within these categories are accepted.
- Access will be denied to vehicles with commercial license tags, sideboards, ladder racks, stake bodies, trucks longer than 14 feet in length, cargo vans, and tag-along trailers. Commercial haulers wishing to use the facility must call **(202) 576-7659** to establish an account.
- All drop-off users must observe posted rules and safety and unloading instructions provided by facility staff.
- All drop-off users are expected to clean all spillage caused by off-loading their waste materials.
- Personal document shredding is limited to five (5) boxes.
- Businesses may not bring any materials to the transfer station.
- Smoking, drinking, foul language and gambling are prohibited.
- Children under the age of 13 and all pets must remain in the vehicle at all times.
- Persons with disabilities and senior citizens are asked to contact our office at **(202) 715-7570** to make advance arrangements for assistance removing items from their vehicles.
