- 2405.3 No person shall park a motor vehicle or trailer, whether occupied or not, otherwise than temporarily for the purpose of and while actually engaged in loading or unloading of passengers or freight in any of the following places:
- (a) On the public parking between the sidewalk space and the building line, except parking shall be permitted on public parking at those locations designated under this title and at locations authorized by permit and upon payment of rent;
- (b) Between a safety zone or channelizing island and the adjacent curb or within ninety feet (90 ft.) of points on the curb immediately opposite the ends of a safety zone or channelizing island unless otherwise indicated by official signs;
- (c) On the roadway side of any vehicle stopped or parked at the edge or curb of a street;
- (d) Within twenty-five feet (25 ft.) of either side of motorists' courtesy mail boxes;
- (e) In any public alley; provided, that parking shall be permitted in a public alley where authorized by a public space permit or where designated by posted sign; and
- (f) In a manner to obstruct the entrance to any garage, parking lot or yard, door, or gate used for service purposes.
- 2. D.C. Municipal Regulations, Title 18, Subsection:
- 2405.3 No person shall park a motor vehicle or trailer, whether occupied or not, otherwise than temporarily for the purpose of and while actually engaged in loading or unloading of passengers or freight in any of the following places:
- (a) On the public parking between the sidewalk space and the building line, except parking shall be permitted on public parking at those locations designated under this title and at locations authorized by permit and upon payment of rent;
- (b) Between a safety zone or channelizing island and the adjacent curb or within ninety feet (90 ft.) of points on the curb immediately opposite the ends of a safety zone or channelizing island unless otherwise indicated by official signs;
- (c) On the roadway side of any vehicle stopped or parked at the edge or curb of a street;
- (d) Within twenty-five feet (25 ft.) of either side of motorists' courtesy mail boxes;
- (e) In any public alley; provided, that parking shall be permitted in a public alley where authorized by a public space permit or where designated by posted sign; and
- (f) In a manner to obstruct the entrance to any garage, parking lot or yard, door, or gate used for service purposes.
- 3. D.C. Municipal Regulations, Title 18, Subsection:
- 2411.1 Except as provided in §§ 2411.2, 2412, 2414, and 2424, parking a motor vehicle on a residential permit parking street within the same zone shall be restricted, as follows:

- (a) To a consecutive two (2) hour period between 7:00 a.m. and 9:00 p.m. Monday through Saturday within the boundaries of Historic Georgetown, and in Ward 5 in the area of 30th Street, N.E., between South Dakota Avenue and Central Avenue, N.E., and Yost Place, N.E., between Vista Street and Bladensburg Road, N. E., between 7 a.m. and midnight; and between 7 a.m. and 8:30 p.m., in all other areas of the District, unless the motor vehicle displays a valid residential permit parking sticker for the designated areas. The residents of specific blocks may petition to change the times for their residential parking permit designation pursuant to § 2411.14.
- (b) The provisions § 2411.1(a) shall apply only to the extent that funds are available to cover the additional costs of personnel and equipment needed to enforce these restrictions.
- (c) Notwithstanding § 2411.1(a), motor vehicles shall have a valid residential permit parking sticker to park at all times in the following locations:
- (d) If, after two (2) hours, a vehicle without the necessary residential permit parking zone sticker has been parked in the same zone, then a notice of infraction specified in section 2601.1 may be issued pursuant to chapter 30, citing a violation of section 2411.1(a).
- (e) A separate notice of infraction specified in section 2601.1, also citing a violation of section 2411.1(a), may be issued pursuant to chapter 30 for each additional two (2) hour period the vehicle has been parked in the same zone.
- 4. D.C. Municipal Regulations, Title 18, Subsection:
- 2405.2 No person shall stand or park a motor vehicle or trailer, whether occupied or not, in any of the following places (including for the purpose of loading or unloading materials), except when necessary to avoid conflict with other traffic, or at the direction of a police officer, traffic control sign, or signal; provided, that a vehicle may stop momentarily to pick up or discharge a passenger or passengers:
- (a) In front of or within five feet (5 ft.) of an alley, public driveway, or private driveway;
- (b) Within ten feet (10 ft.) of a fire hydrant;
- (c) Except as provided in § 2411.21 of this title, within forty feet (40 ft.) of the intersection of curb lines of intersecting streets or within twenty-five feet (25 ft.) of the intersection of curb lines on the far (non-approach) side of a one-way street; except that trucks vending ice cream shall park curbside when stopping to make a sale, as close as possible to a pedestrian cross-walk without entering the intersection, and without unduly interfering with the flow of traffic;
- (d) Within twenty-five feet (25 ft.) of the approach side of any "STOP" or "YIELD" sign located at the side of the roadway;
- (e) Within fifty feet (50 ft.) of a railroad crossing;
- (f) Within twenty feet (20 ft.) of a fire station driveway entrance;
- (g) In or on any street or roadway when such parking will reduce the width of the open roadway to less than ten feet (10 ft.);
- (h) In front of any barricade or sign that has been placed for the purpose of closing the street; or
- (i) In a fire lane located on public or private space.
- 5. D.C. Municipal Regulations, Title 18, Subsection:
- 2405.1 No person shall stop, stand, or park a motor vehicle or trailer in any of the following places, except when necessary to avoid conflict with other traffic, in compliance with law, or at the direction of a police officer or traffic control device:

- (a) Within an intersection;
- (b) On a crosswalk;
- (c) Alongside or opposite any street excavation or obstruction when stopping, standing, or parking would obstruct traffic;
- (d) Upon any bridge, viaduct, or other elevated structure, freeway, highway tunnel, or ramps leading to or from such structures, or within a highway tunnel;
- (e) On any median, channelizing island, or safety zone, whether made of concrete, grass, or other material and with curbs or otherwise delineated by solid yellow or white lines;
- (f) In any driveway, alley entrance, or other way when stopping, standing or parking would obstruct the flow of pedestrians or other lawful traffic upon any sidewalk:
- (g) In a bicycle lane; or
- (h) On the sidewalk.
- 6. D.C. Municipal Regulations, Title 18, Subsection:
- 2409.3 (a) Except as provided in paragraph (b) of this subsection, no person shall stand or park a vehicle in a valet parking zone or valet staging zone unless authorized to do so; in a bus stand, stop, or zone, other than a bus authorized to use the bus stand, stop, or zone; in a taxicab stand, other than a taxicab authorized to use the taxicab stand; or in a sightseeing stand, other than a sightseeing vehicle authorized to use the sightseeing stand.
- (b) A driver of a passenger vehicle may stop momentarily in a stand, stop, or zone described in paragraph (a) of this subsection for the purpose of and while actually picking up or discharging passengers, as long as such stopping does not interfere with any vehicle, bus, taxicab, or sightseeing vehicle about to enter the stand or zone designated for the use of such vehicle.
- 7. D.C. Municipal Regulations, Title 18, Subsection:
- 2405.1 No person shall stop, stand, or park a motor vehicle or trailer in any of the following places, except when necessary to avoid conflict with other traffic, in compliance with law, or at the direction of a police officer or traffic control device:
- (a) Within an intersection;
- (b) On a crosswalk;
- (c) Alongside or opposite any street excavation or obstruction when stopping, standing, or parking would obstruct traffic;
- (d) Upon any bridge, viaduct, or other elevated structure, freeway, highway tunnel, or ramps leading to or from such structures, or within a highway tunnel;
- (e) On any median, channelizing island, or safety zone, whether made of concrete, grass, or other material and with curbs or otherwise delineated by solid yellow or white lines;

- (f) In any driveway, alley entrance, or other way when stopping, standing or parking would obstruct the flow of pedestrians or other lawful traffic upon any sidewalk:
- (g) In a bicycle lane; or
- (h) On the sidewalk.
- 8. D.C. Municipal Regulations, Title 18, Subsection:
- 2400.2 A person shall stand or park a vehicle on a two-way street with the right-hand wheels of the vehicle within twelve inches (12 in.) of the right curb or edge of the roadway.
- 2400.3 On a one-way street, a vehicle may be parked in the same manner as on a two-way street or may park with the left-hand wheels of the vehicle adjacent to and within twelve inches (12 in.) of the left-hand curb.
- 9. D.C. Municipal Regulations, Title 18, Subsection:
- 2400.6 Except as provided in § 2403, the provisions of this chapter prohibiting the standing or parking of a vehicle shall apply at all times, or at those times herein specified, or as indicated on official signs, except when it is necessary to stop a vehicle to avoid conflict with other traffic or in compliance with the direction of a police officer or official traffic control device.
- 2400.7 The provisions of this chapter imposing a time limit on parking shall not relieve any person from the duty to observe other and more restrictive provisions prohibiting or limiting the stopping, standing, or parking of vehicles in specified places or at specified times.
- 10. D.C. Municipal Regulations, Title 18, Subsection:
- 2407.23 Whenever a sign is erected indicating that parking is prohibited or reserved under this section, it shall be unlawful to park any unauthorized vehicle in violation of the parking restrictions stated on the sign.
- 2407.24 A Sign prohibiting or reserving parking shall be erected at least 24 hours in advance in a non-residentially zoned area. If a sign is erected in a residentially zoned area, the sign prohibiting or reserving parking shall be erected at least 72 hours in advance. The Director for extraordinary circumstances shown may waive this required advance notice for good cause.
- 11. D.C. Municipal Regulations, Title 18, Subsection:
- 2418.3 No person owning, operating, or having control over the engine of a gasoline or diesel powered motor vehicle on public or private space, including the engine of a public vehicles for hire, buses with a seating capacity of twelve (12) or more persons, and school buses or any vehicle transporting students, shall allow that engine to idle for more than three (3) minutes while the motor vehicle is parked, stopped, or standing, including for the purpose of operating air conditioning equipment in those vehicles, except as follows:
- (a) To operate private passenger vehicles;
- (b) To operate power takeoff equipment, including dumping, cement mixers, refrigeration systems, content delivery, winches, or shredders; or

- (c) To idle the engine for no more than five (5) minutes to operate heating equipment when the ambient air temperature is thirty-two degrees Fahrenheit (32° F) or below.
- 12. D.C. Municipal Regulations, Title 18, Subsection:
- 2405.2 No person shall stand or park a motor vehicle or trailer, whether occupied or not, in any of the following places (including for the purpose of loading or unloading materials), except when necessary to avoid conflict with other traffic, or at the direction of a police officer, traffic control sign, or signal; provided, that a vehicle may stop momentarily to pick up or discharge a passenger or passengers:
- (a) In front of or within five feet (5 ft.) of an alley, public driveway, or private driveway;
- (b) Within ten feet (10 ft.) of a fire hydrant;
- (c) Except as provided in § 2411.21 of this title, within forty feet (40 ft.) of the intersection of curb lines of intersecting streets or within twenty-five feet (25 ft.) of the intersection of curb lines on the far (non-approach) side of a one-way street; except that trucks vending ice cream shall park curbside when stopping to make a sale, as close as possible to a pedestrian cross-walk without entering the intersection, and without unduly interfering with the flow of traffic;
- (d) Within twenty-five feet (25 ft.) of the approach side of any "STOP" or "YIELD" sign located at the side of the roadway;
- (e) Within fifty feet (50 ft.) of a railroad crossing;
- (f) Within twenty feet (20 ft.) of a fire station driveway entrance;
- (g) In or on any street or roadway when such parking will reduce the width of the open roadway to less than ten feet (10 ft.);
- (h) In front of any barricade or sign that has been placed for the purpose of closing the street; or
- (i) In a fire lane located on public or private space.
- 13. D.C. Municipal Regulations, Title 18, Subsection:
- 2400.1 No person shall stand or park a vehicle in a roadway other than parallel with the edge of the roadway headed in the direction of lawful traffic movement.
- 2400.2 A person shall stand or park a vehicle on a two-way street with the right-hand wheels of the vehicle within twelve inches (12 in.) of the right curb or edge of the roadway.
- 2400.3 On a one-way street, a vehicle may be parked in the same manner as on a two-way street or may park with the left-hand wheels of the vehicle adjacent to and within twelve inches (12 in.) of the left-hand curb.
- 2400.8 A person may park a motorcycle or motorized bicycle in a direction other than parallel with the edge of the roadway, including perpendicular with the curb, if the motorcycle or motorized bicycle does not obstruct the flow of traffic.
- 14. D.C. Municipal Regulations, Title 18, Subsection:
- 2402.6 No person shall park a vehicle in any place designated as a loading zone during the hours applying to such zone, except commercial vehicles for the purpose of loading or unloading; Provided, that a vehicle may stop momentarily at a loading zone to pick up a passenger or passengers if such Stopping does not interfere with any commercial vehicle which is about to enter or waiting to enter the loading zone.

Commercial Vehicle - any vehicle with more than three (3) wheels and:

- (a) Greater than twenty-two (22) feet in length; or
- (b) Used or maintained for transporting freight, merchandise, or other commercial loads or property.
- (c) Described as a "commercial" vehicle on its certificate of title in accordance with 18 DCMR § 403.4; or
- (d) Considered a commercial vehicle by the Director pursuant to 18 DCMR §413.13 because it has an irremovable commercial advertisement or insignia.
- 15. D.C. Municipal Regulations, Title 18, Subsection:
- 2404.5 No person shall stop, stand, or park in a parking meter zone any vehicle which exceeds the designated length of the meter zone.
- 16. D.C. Municipal Regulations, Title 18, Subsection:
- 2404.7 No person shall purchase more time than allowed for the parking meter zone.
- 17. D.C. Municipal Regulations, Title 18, Subsection:
- 2404.6 Immediately after parking a motor vehicle, the operator shall pay for the amount of parking time desired and, if a receipt is issued, place the receipt on the passenger side of the dashboard of the vehicle so that it is clearly visible through the windshield of the vehicle. The space may then be used by the vehicle during the parking limit indicated on the single-space or multi-space parking meter for that space or on the receipt issued, as is applicable, or for the amount of time that is confirmed through a pay-by-phone system.
- 18. D.C. Municipal Regulations, Title 18, Subsection:
- 2404.4 No person shall park or cause to be parked any vehicle so that the vehicle is not within the area between the designated standards or other marking(s) delimiting the parking space.
- 19. D.C. Municipal Regulations, Title 18, Subsection:
- 2420.2 The holder of a special parking permit issued in accordance with paragraph (e), § 6, of the District of Columbia Traffic Act, shall not do any of the following:
- (a) Park a vehicle in any reserved official space less than four (4) blocks from any building in which he or she is permanently or regularly assigned or employed;
- (b) Park a vehicle in any reserved official space at any time in violation of existing traffic regulations otherwise applicable to the area in which the space is located; or
- (c) Park a vehicle beyond the time limit specified on posted signs establishing the space.
- 20. D.C. Municipal Regulations, Title 18, Subsection:
- 2404.3 Except as provided in section 2426, no person shall park or cause, allow, permit, or suffer any vehicle registered in his or her name to be parked overtime or beyond the lawful period of time indicated on the meter.
- 21. D.C. Municipal Regulations, Title 18, Subsection:
- 2404.8 Except as provided in §§ 2404.9 and 2406.18, a vehicle shall be considered illegally parked if:

- (a) The amount of time paid for at a single-space or multi-space parking meter has lapsed;
- (b) The expiration time indicated on the parking meter receipt displayed on the vehicle has lapsed;
- (c) The vehicle does not display a receipt in the manner required by § 2404.6; or;
- (d) The amount of time paid for using the pay-by-phone system has lapsed.
- 22. D.C. Municipal Regulations, Title 18, Subsection:
- 2400.1 No person shall stand or park a vehicle in a roadway other than parallel with the edge of the roadway headed in the direction of lawful traffic movement.
- 2400.8 A person may park a motorcycle or motorized bicycle in a direction other than parallel with the edge of the roadway, including perpendicular with the curb, if the motorcycle or motorized bicycle does not obstruct the flow of traffic.
- 23. D.C. Municipal Regulations, Title 18, Subsection:
- 2405.3 No person shall park a motor vehicle or trailer, whether occupied or not, otherwise than temporarily for the purpose of and while actually engaged in loading or unloading of passengers or freight in any of the following places:
- (a) On the public parking between the sidewalk space and the building line, except parking shall be permitted on public parking at those locations designated under this title and at locations authorized by permit and upon payment of rent;
- (b) Between a safety zone or channelizing island and the adjacent curb or within ninety feet (90 ft.) of points on the curb immediately opposite the ends of a safety zone or channelizing island unless otherwise indicated by official signs;
- (c) On the roadway side of any vehicle stopped or parked at the edge or curb of a street;
- (d) Within twenty-five feet (25 ft.) of either side of motorists' courtesy mail boxes;
- (e) In any public alley; provided, that parking shall be permitted in a public alley where authorized by a public space permit or where designated by posted sign; and
- (f) In a manner to obstruct the entrance to any garage, parking lot or yard, door, or gate used for service purposes.
- 24. D.C. Municipal Regulations, Title 18, Subsection:
- 2406.5 The Director is authorized to have signs prohibiting parking placed for a distance not to exceed sixty feet (60 ft.) along the curb in front of or along side of any building occupied by an embassy or legation of any foreign country, except for those vehicles bearing diplomatic motor vehicle identification tags.

 25. D.C. Municipal Regulations, Title 18, Subsection:
- 2406.2 The Director is authorized to have signs prohibiting parking placed on streets adjacent to any school on school days, or playgrounds between the hours of 7:00 a.m. and 6:30 p.m., or for such lesser time as the Director may, in his or her discretion, establish.
- 26. D.C. Municipal Regulations, Title 18, Subsection:
- 2405.1 No person shall stop, stand, or park a motor vehicle or trailer in any of the following places, except when necessary to avoid conflict with other traffic, in

compliance with law, or at the direction of a police officer or traffic control device:

- (a) Within an intersection;
- (b) On a crosswalk;
- (c) Alongside or opposite any street excavation or obstruction when stopping, standing, or parking would obstruct traffic;
- (d) Upon any bridge, viaduct, or other elevated structure, freeway, highway tunnel, or ramps leading to or from such structures, or within a highway tunnel;
- (e) On any median, channelizing island, or safety zone, whether made of concrete, grass, or other material and with curbs or otherwise delineated by solid yellow or white lines;
- (f) In any driveway, alley entrance, or other way when stopping, standing or parking would obstruct the flow of pedestrians or other lawful traffic upon any sidewalk:
- (g) In a bicycle lane; or
- (h) On the sidewalk.
- 27. D.C. Municipal Regulations, Title 18, Subsection:
- 2409.3 (a) Except as provided in paragraph (b) of this subsection, no person shall stand or park a vehicle in a valet parking zone or valet staging zone unless authorized to do so; in a bus stand, stop, or zone, other than a bus authorized to use the bus stand, stop, or zone; in a taxicab stand, other than a taxicab authorized to use the taxicab stand; or in a sightseeing stand, other than a sightseeing vehicle authorized to use the sightseeing stand.
- (b) A driver of a passenger vehicle may stop momentarily in a stand, stop, or zone described in paragraph (a) of this subsection for the purpose of and while actually picking up or discharging passengers, as long as such stopping does not interfere with any vehicle, bus, taxicab, or sightseeing vehicle about to enter the stand or zone designated for the use of such vehicle.
- 28. D.C. Municipal Regulations, Title 18, Subsection:
- 2400.6 Except as provided in § 2403, the provisions of this chapter prohibiting the standing or parking of a vehicle shall apply at all times, or at those times herein specified, or as indicated on official signs, except when it is necessary to stop a vehicle to avoid conflict with other traffic or in compliance with the direction of a police officer or official traffic control device.
- 29. D.C. Municipal Regulations, Title 18, Subsection:
- 2000.4 The driver of any vehicle shall obey the instructions of any official traffic control device applicable to the vehicle which has been placed in accordance with the provisions of this subtitle, unless otherwise directed by a police officer, subject to the exceptions granted the driver of an authorized emergency vehicle in this chapter.

Park or Parking - the standing of a vehicle, whether occupied or not, other than temporarily for the purpose of, and while actually engaged in, loading or unloading merchandise or passengers.

30. D.C. Municipal Regulations, Title 18, Subsection:

2000.4 The driver of any vehicle shall obey the instructions of any official traffic control device applicable to the vehicle which has been placed in accordance with the provisions of this subtitle, unless otherwise directed by a police officer, subject to the exceptions granted the driver of an authorized emergency vehicle in this chapter.

Park or Parking - the standing of a vehicle, whether occupied or not, other than temporarily for the purpose of, and while actually engaged in, loading or unloading merchandise or passengers.

31. D.C. Municipal Regulations, Title 18, Subsection:

2400.5 No person shall park a vehicle upon any roadway for the principal purpose of doing either of the following:

- (a) Displaying the vehicle for sale; or
- (b) Greasing or repairing the vehicle, except minor repairs necessitated by an emergency.
- 32. D.C. Municipal Regulations, Title 18, Subsection:
- 2418.1 No persons driving or in charge of a motor vehicle shall permit it to stand unattended without first stopping the engine, locking the ignition, removing the key, and effectively setting the brake.
- 2418.2 In addition to the requirements of § 2418.1, whenever a motor vehicle is standing on a grade, the driver or person in charge of the vehicle shall not permit it to stand unattended without first turning the front wheels to the curb or side of the highway.

- (a) When an issuing officer observes a motor vehicle housed within the District that does not display District registration tags or a current reciprocity sticker the issuing officer shall record the following:

- 422.1 Whenever a motor vehicle or trailer for which District of Columbia registration is required is being operated or left standing upon any public highway, such vehicle shall display two (2) current identification tags, one (1) on the front and the other on the rear; except that motor vehicles need only display a special use identification tag on the rear of the vehicle only.
- 36. D.C. Municipal Regulations, Title 18, Subsection:

- 604.4 A registrant, or any person desiring registration, to whom a rejection sticker was issued shall not park or permit the parking of the vehicle on any public space after the expiration date of the rejection sticker.
- 37. D.C. Municipal Regulations, Title 18, Subsection:
- 601.1 Inspections shall be made and stickers obtained with respect to the items of equipment designated by the Director.
- 603.2 The inspection sticker will permit the operation and use of the motor vehicle or trailer until the registrant or person desiring registration is notified by the Director to present the motor vehicle or trailer for another inspection; provided, that the registrant or other person has complied with the provisions of this title and all other applicable provisions of law.
- 38. D.C. Municipal Regulations, Title 18, Subsection:
- 602.3 Vehicles bearing special bus identification, current dealer tags, transport tags, special use paper tags, or historic motor vehicle tags shall be exempt from the inspection sticker requirements of this section.
- 602.4 It shall be unlawful for any person to operate, park, or permit to be operated or parked on public space any vehicle bearing current District of Columbia tags, except a vehicle exempt under the provisions of § 602.3, unless there is displayed on the right side of the vehicle's windshield one of the following:
- (a) A current District of Columbia inspection sticker;
- (b) A temporary sticker issued by the Director; and
- (c) A temporary registration certificate issued by a registered District of Columbia dealer or repair shop when transferring ownership for registration purposes.
- 602.7 A vehicle owned by a non-resident and currently registered in another jurisdiction shall display the proper inspection sticker issued for the vehicle in accordance with the requirements of the issuing jurisdiction.

- 39. D.C. Municipal Regulations, Title 18, Subsection:
- 2409.3 (a) Except as provided in paragraph (b) of this subsection, no

person shall stand or park a vehicle in a valet parking zone or valet staging zone unless authorized to do so; in a bus stand, stop, or zone, other than a bus authorized to use the bus stand, stop, or zone; in a taxicab stand, other than a taxicab authorized to use the taxicab stand; or in a sightseeing stand, other than a sightseeing vehicle authorized to use the sightseeing stand.

- (b) A driver of a passenger vehicle may stop momentarily in a stand, stop, or zone described in paragraph (a) of this subsection for the purpose of and while actually picking up or discharging passengers, as long as such stopping does not interfere with any vehicle, bus, taxicab, or sightseeing vehicle about to enter the stand or zone designated for the use of such vehicle.
- 2409.4 The driver of any vehicle parked in a bus, taxicab, or sightseeing stand in accordance with § 2409.3, shall at all times remain within five feet (5 ft.) of the vehicle.
- 40. D.C. Municipal Regulations, Title 18, Subsection:
- 2000.4 The driver of any vehicle shall obey the instructions of any official traffic control device applicable to the vehicle which has been placed in accordance with the provisions of this subtitle, unless otherwise directed by a police officer, subject to the exceptions granted the driver of an authorized emergency vehicle in this chapter.

Standing - halting a vehicle, whether occupied or not, except when necessary to avoid conflict with other traffic or in compliance with the directions of a police officer, traffic control sign, or traffic signal; Provided, that a vehicle may stop momentarily to pick up or discharge a passenger or passengers actually waiting at the curb, but not for loading materials.

- 41. D.C. Municipal Regulations, Title 18, Subsection:
- 2417.1 In addition to the Severe Weather Traffic Controls contained in § 2219, whenever snow, sleet, or freezing rain is creating a condition making it necessary to prohibit the parking of motor vehicles on Snow Emergency Routes, or whenever on the basis of a firm forecast by the United States Weather Bureau of snow, sleet, or freezing rain such that the weather conditions so forecast may create a condition making it necessary to prohibit the parking of motor vehicles on Snow Emergency Routes, the Director shall be authorized to declare a snow emergency so as to prohibit parking on Snow Emergency Routes. This prohibition shall become effective not less than one (1) hour after the announcement or at a later time specified by the Director so as to prohibit the parking on any or all of the following streets:
- (a) Designated Snow Emergency Routes as listed in § 4024;
- (b) The "Even" and "Odd" sides of designated Snow Emergency Routes; and
- (c) The side of designated Snow Emergency Routes streets with an "a.m." or "p.m." rush hour, "no standing" or "no parking" restriction.
- 2417.2 After the effective time of the prohibition, no person shall park any vehicle or permit any vehicle to remain parked on a Snow Emergency Route; Provided, that if a fall of snow, sleet, or freezing rain occurs after 11:30 p.m., and prior to 7:00 a.m., and the Director has not announced, prior to 11:30 p.m., that parking on Snow Emergency Routes is prohibited after a specified time, a vehicle parked on a Snow Emergency Route may remain so parked until 7:00 a.m.
- 42. D.C. Municipal Regulations, Title 18, Subsection:
- 429.1 Motor vehicle owners and operators who are not legal residents of the District but who are housing a motor vehicle within the District shall comply with §§ 411.3, 411.6, 411.7, and 411.8.

- 411.5 No reciprocity sticker issued for a period of one hundred and eighty (180) days shall be issued to the same person within one (1) year from the expiration date of the previous reciprocity sticker.
- 411.6 The fee for a one hundred and eighty (180) day reciprocity sticker is two hundred and fifty dollars (\$ 250).
- 411.7 REPEALED
- 422.3 A vehicle owned by a non-resident and currently registered in another jurisdiction shall display the proper identification tag or tags issued for the vehicle in accordance with the requirements of the issuing jurisdiction; provided, that the tags are displayed in accordance with §§ 422.4, 422.5, 422.6, and 422.8.
- 422.4 Owner's identification tags shall at all times be securely fastened in a horizontal position to the vehicle for which they are issued so as to prevent the tags from swinging and at a height of not less than twelve inches (12 in.) from the ground, measuring from the bottom of the tags, in a place and position to be clearly visible.
- 422.5 Identification tags shall be maintained free from foreign materials and in a clearly legible condition. For the purposes of this subsection, foreign materials shall include any non- transparent materials placed on or over the tag(s); any expired or any unauthorized decals or stickers; or any markings or attachments of any kind, except as permitted by § 422.6.
- 422.6 No sign or emblem more than twenty-four square inches (24 in.<2>) in area shall be attached to any license tag bracket nor shall any sign or emblem be so located as to obstruct from view any part of the identification tags.
- 422.8 No person shall operate a vehicle where the identification tag's identifying numbers or letters are covered with glass, plastic, or any other type of material or substance.
- 43. D.C. Municipal Regulations, Title 18, Subsection:
- 2423.1 No person shall park any vehicle or permit any vehicle to remain parked during the times and days indicated on a Street Cleaning Route.
- 2423.2 Parking prohibitions for street cleaning shall override any less restrictive parking privileges at designated locations during the times and days specified, except for parking restrictions imposed by the District during snow emergencies on designated snow emergency routes.
- 2423.3 When the opposite block face is restricted for street cleaning purposes, parking shall be allowed on designated streets that are otherwise restricted during the times and days specified.

- (e) The principal entrance of the embassy or legation of any foreign country.

- 2404.7 No person shall purchase more time than allowed for the parking meter zone.
- 2424.12 The civil infractions and their respective fines set forth in § 2404 shall apply to the provisions in this § 2424 associated with the Ballpark Performance Parking Pilot Zone, except that fines during Ballpark Events shall be double the fines set forth in § 2404 or set forth elsewhere in this Chapter for non-Ballpark Event times.
- 47. D.C. Municipal Regulations, Title 18, Subsection:
- 2404.8 Except as provided in §§ 2404.9 and 2406.18, a vehicle shall be considered illegally parked if:
- (c) The vehicle does not display a receipt in the manner required by § 2404.6; or;
- 2404.9 Parking meter zones may be used without charge at times when the signs and meters in those zones indicate payment is not needed.
- 2404.18 Except as provided in § 2424, the Director is authorized, by administrative rulemaking, to specify the street segments or off-street public parking facilities which are in each of the Rate Zones established above.
- 2424.12 The civil infractions and their respective fines set forth in § 2404 shall apply to the provisions in this § 2424 associated with the Ballpark Performance Parking Pilot Zone, except that fines during Ballpark Events shall be double the fines set forth in § 2404 or set forth elsewhere in this Chapter for non-Ballpark Event times.
- 48. D.C. Municipal Regulations, Title 18, Subsection:
- 2404.5 No person shall stop, stand, or park in a parking meter zone any vehicle which exceeds the designated length of the parking meter zone.
- 2424.12 The civil infractions and their respective fines set forth in § 2404 shall apply to the provisions in this § 2424 associated with the Ballpark Performance Parking Pilot Zone, except that fines during Ballpark Events shall be double the fines set forth in § 2404 or set forth elsewhere in this Chapter for non-Ballpark Event times.
- 49. D.C. Municipal Regulations, Title 18, Subsection:
- 2404.3 Except as provided in section 2426, no person shall park or cause, allow, permit, or suffer any vehicle registered in his or her name to be parked overtime or beyond the lawful period of time indicated on the meter.
- 2424.12 The civil infractions and their respective fines set forth in § 2404 shall apply to the provisions in this § 2424 associated with the Ballpark Performance Parking Pilot Zone, except that fines during Ballpark Events shall be double the fines set forth in § 2404 or set forth elsewhere in this Chapter for non-Ballpark Event times.
- 50. D.C. Municipal Regulations, Title 18, Subsection:
- 2704.3 Except as provided in § 2704.4, a vehicle displaying a special license tag or special parking permit for the physically disabled, whether issued by the District or any other jurisdiction, shall be subject to any time limitation or meter payment requirement established for any space in which the vehicle is parked, as indicated on the sign or meter denoting the space.
- 2704.4 Until such time as the study described in § 2406.9(f) is completed and the Director of the District Department of Transportation has established reserved parking spaces in accordance with the conclusions reached by the Director in the study, individuals issued special license tags for persons with a physical

disability, regardless of which state, territory, or possession of the United States issued the license tags and individuals issued special parking permits persons with a physical disability by the District may park a motor vehicle without cost for double the posted time period in parking zones that are restricted as to the length of time parking is permitted, provided that:

Stopping (when prohibited)-halting a vehicle except to avoid conflict with other traffic or in compliance with the directions of a police officer or a traffic control sign or signal.

52. D.C. Municipal Regulations, Title 18, Subsection:

2404.8 Except as provided in § 2404.9, a vehicle shall be considered illegally parked if:

(b) The expiration time indicated on the parking meter receipt displayed on the vehicle has lapsed; or

2404.6 Immediately after parking a motor vehicle, the operator shall pay for the amount of parking time desired and, if a receipt is issued, place the receipt on the passenger side of the dashboard of the vehicle so that it is clearly visible through the windshield of the vehicle. The space may then be used by the vehicle during the parking limit indicated on the single-space or multi-space parking meter for that space or on the receipt issued, as is applicable, or for the amount of time that is confirmed through a pay-by-phone system.

2404.9 Parking meter zones may be used without charge at times when the signs and meters in those zones indicate payment is not needed.

53. D.C. Municipal Regulations, Title 18, Subsection:

2404.8 Except as provided in § 2404.9, a vehicle shall be considered illegally parked if:

(c) The vehicle does not display a receipt in the manner required by § 2404.6.

2404.6 Immediately after parking a motor vehicle, the operator shall pay for the amount of parking time desired and, if a receipt is issued, place the receipt on the passenger side of the dashboard of the vehicle so that it is clearly visible through the windshield of the vehicle. The space may then be used by the vehicle during the parking limit indicated on the single-space or multi-space parking meter for that space or on the receipt issued, as is applicable, or for the amount of time that is confirmed through a pay-by-phone system.

2404.9 Parking meter zones may be used without charge at times when the signs and meters in those zones indicate payment is not needed.

54. D.C. Municipal Regulations, Title 18, Subsection:

2406.12 The Director is authorized to establish reserved on-street parking spaces for the exclusive use of car-sharing vehicles provided:

(a) Parking in spaces established pursuant to this subsection shall be permitted only for vehicles registered to and operated by any car-sharing company in the

District that enters into a one-year contract with the District that shall include, but not be limited to, the following provisions:

- (1) The company must indemnify the District against legal liabilities associated with the use of public space with car-sharing operations;
- (2) All company car-sharing vehicles parked in the District, regardless of whether they are located on private or public space, must be registered in the District of Columbia and display District license plates;
- (3) Up to seven (7) cars must be located in low-income neighborhoods as identified by DDOT even if such locations are not desired or requested by the company;
- (4) The company must provide a list of pre-existing private parking locations and agree not to eliminate any of these private parking locations until the size of their District fleet exceeds the pre-existing fleet size by 50%. Thereafter, the company may eliminate one private parking space for each additional public parking space up to a maximum of 25; and
- (5) The company shall provide DDOT with data to help evaluate the impact of the program.
- (b) These one-year contracts may be renewed, renegotiated or terminated based upon an evaluation of results. The Department reserves the right to charge a fee for the reservation of public space should it determine that doing so is in the public interest;
- (c) Unauthorized vehicles parked in such spaces shall be in violation of and subject to the fine set forth in § 2601; and
- (d) The Director may authorize the Department of Motor Vehicles to issue special license plates pursuant to this subsection properly identifying carsharing vehicles as such, in order to aid in the enforcement of 2406.12(c).
- 55. D.C. Municipal Regulations, Title 18, Subsection:
- 2402.10 Except as provided in § 2402.11, a vehicle shall be considered illegally parked if:
- (a) A multi-space parking meter indicates overtime parking with respect to the parking metered loading zone in which the vehicle is parked;
- (b) The expiration time indicated on the parking meter receipt displayed on the vehicle has lapsed;
- (c) The vehicle does not display a receipt in the manner required by § 2402.8; or
- (d) The vehicle does not display a receipt.
- 56. D.C. Municipal Regulations, Title 18, Subsection:
- 2402.10 Except as provided in § 2402.11, a vehicle shall be considered illegally parked if:
- (a) A multi-space parking meter indicates overtime parking with respect to the parking metered loading zone in which the vehicle is parked;
- (b) The expiration time indicated on the parking meter receipt displayed on the vehicle has lapsed;

§ 50-2421.03. Unlawful acts.

It shall be a violation of Chapter 23 of this title for any person to park, leave unattended, or store:

- (1) An abandoned or dangerous vehicle on public space;
- (2) Any motor vehicle on private property without the consent of the property owner; or
- (3) An abandoned or dangerous vehicle on private property, even with the consent of the property owner, unless the vehicle is:
- (A) Kept in a lawful enclosed structure or building completely shielded from the view of individuals on the adjoining properties; or
- (B) Lawfully stored or kept on the property of a business engaged in the lawful repair, storage, salvage, or disposal of vehicles.

§ 50-2421.04. Removal of abandoned and dangerous vehicles from public space; penalties.

- (a) The District government, or any towing company at the direction of the Department shall remove an abandoned or dangerous vehicle parked, left, or stored on public space in violation of § 50-2421.03(1), as follows:
- (1) An abandoned vehicle shall be removed 48 hours after a warning notice has been conspicuously placed on the vehicle. The warning notice shall be placed at the first sighting of a vehicle that meets the physical characteristics of an abandoned vehicle. The warning notice shall indicate the date and time it was placed and the date and time that the District is authorized to remove, impound, or dispose of the vehicle if the vehicle is not moved. The notice shall also include a statement indicating the vehicle will not be towed if the owner or other authorized person certifies to the Department that the vehicle is undergoing emergency repair. The notice shall provide a telephone number, and website if any, that will inform the owner how to accomplish the certification.
- (2) A dangerous vehicle shall be immediately removed without the placement of a warning notice.
- (b) If more than one basis exists for removing a vehicle, whether stated in this subchapter or in any other law or regulation, the shortest removal period shall apply, including removal without a warning notice.
- (c) No vehicle shall be removed from public space pursuant to this section until a notice of infraction is conspicuously placed on the vehicle.
- (d) Except as provided in this section, it shall be unlawful for any person, except the owner, a person authorized by the owner in writing, an employee of the District government in connection with the performance of official duties, or a tow crane operator who has valid authorization from the District government, to do any of the following:
- (1) Tamper with, remove, or attempt to tamper with or remove any vehicle owned by another person;
- (2) Tamper with, remove, or attempt to tamper with or remove any vehicle that is on public space and to which a District government warning notice that relates to the removal of the vehicle has been affixed; or
- (3) Remove, mutilate, or attempt to remove or mutilate the warning notice.
- (e) Any person violating the provisions of subsection (d) of this section, shall be prosecuted by the Office of the Corporation Counsel, and shall be punished by a fine of not more than \$500, imprisonment of not more than 90 days, or both.


73. D.C. Municipal Regulations, Title 18, Subsection:

50-2421.03. Unlawful acts. It shall be a violation of the District of Columbia Traffic Adjudication Act of 1978, effective September 12, 1978 (D.C. Law 2-104; D.C. Official Code § 50-2301.01 et seq.), for any person to park, leave unattended, or store:


(1) An abandoned or dangerous vehicle on public space;

- (2) Any motor vehicle on private property without the consent of the property owner; or
- (3) An abandoned or dangerous vehicle on private property, even with the consent of the property owner, unless the vehicle is:
- (A) Kept in a lawful enclosed structure or building completely shielded from the view of individuals on the adjoining properties; or
- (B) Lawfully stored or kept on the property of a business engaged in the lawful repair, storage, salvage, or disposal of vehicles.
- 74. D.C. Municipal Regulations, Title 18, Subsection:
- 2405.1 No person shall stop, stand, or park a motor vehicle or trailer in any of the following places, except when necessary to avoid conflict with other traffic, in compliance with law, or at the direction of a police officer or traffic control device:
- (a) Within an intersection;
- (b) On a crosswalk;
- (c) Alongside or opposite any street excavation or obstruction when stopping, standing, or parking would obstruct traffic;
- (d) Upon any bridge, viaduct, or other elevated structure, freeway, highway tunnel, or ramps leading to or from such structures, or within a highway tunnel;
- (e) On any median, channelizing island, or safety zone, whether made of concrete, grass, or other material and with curbs or otherwise delineated by solid yellow or white lines;
- (f) In any driveway, alley entrance, or other way when stopping, standing or parking would obstruct the flow of pedestrians or other lawful traffic upon any sidewalk;
- (g) In a bicycle lane; or
- (h) On the sidewalk.
- 75. D.C. Municipal Regulations, Title 18, Subsection:
- 2421.1 Any unattended vehicle found parked in violation of any traffic regulation, except overtime parking of less than twenty-four (24) hours, may, by or under the direction of a member or members of the Metropolitan Police force or employees of the Department of Public Works, either by towing or otherwise, be removed or conveyed to any street where parking is not prohibited (except for more than eighteen (18) hours) or be removed or conveyed to and impounded in or at the police precinct station of the police precinct in which the vehicle may be found, or any other place designated by the Director. The Director may authorize a vehicle to be towed by, or impounded at a facility operated by, a private tow crane operator.
- 76. D.C. Municipal Regulations, Title 18, Subsection:
- 2406.14 The Director is authorized to establish reserved on-street parking spaces for the exclusive use of charging electric vehicles, provided:
- (a) Parking in spaces established pursuant to this subsection shall be permitted only for electric vehicles while they are being charged in accordance with the guidelines provided on the charging station;
- (b) Unauthorized vehicles parked in such spaces shall be in violation of this subsection and subject to the fine set forth in § 2601; and


- (c) A vehicle occupying a space established pursuant to this subsection shall be required to pay the parking meter rates for that space in addition to any inconvenience fee specified in 24 DCMR § 225.1(r).
- 2406.15 On-street parking spaces reserved for the exclusive use of charging electric vehicles shall be considered part of the Premium Demand Parking Meter Rate Zone.
- 2406.16 Vehicles may not park and charge for more than four (4) hours between 6:00 a.m. and 10:00 p.m. Monday through Saturday at an on-street parking space reserved for the exclusive use of charging electric vehicles.
- 2406.17 Notwithstanding §§ 2404.9 and 2406.16, on-street parking spaces reserved for the exclusive use of charging electric vehicles, and the associated fees, shall be in effect at all times.
- 77. D.C. Municipal Regulations, Title 18, Subsection:
- 2405.5 The following may not be parked on any public thoroughfare in front of, alongside, or in the rear of any private dwelling or apartment, house of worship, school, playground, or hospital; provided, a vehicle may be parked in front of, alongside, or in the rear of such property while engaged in work at such place for which the vehicle is reasonably necessary:
- (a) Any passenger vehicle with a seating capacity of more than fifteen (15) passengers;
- (b) A boat;
- (c) A trailer, whether loaded or unloaded;
- (d) Any vehicle longer than twenty-two feet (22 ft.) or wider than eight feet (8 ft.); or
- (e) Any vehicle that has been designed or modified to haul trash, junk, or debris.
- 2405.6 No vehicle described in § 2405.5(a) through (e) may be parked alongside or around any public park except in stands established in accordance with this chapter.




