## RESIDENTIAL STREET SWEEPING SERVICES

Procedures for the application for the residential street sweeping program and installation of the NO PARKING SIGNS FOR STREET CLEANING are as follows:

1. A petition must be completed for each street location.
a. A minimum of three (3) blocks is required to be considered for the program.
b. For traffic safety reasons, petitions will not be considered
i. in the middle of a one-way street,
ii. rush hour restriction roadways, and
iii. commercial corridors roadways.
2. Petitions - for both applications and removals - must have the signatures of individuals representing at least eighty percent $\mathbf{( 8 0 \%}$ ) of the residences on the block.
a. If an apartment building is located within the block, then each apartment unit is to be counted as a separate residence.
b. SACD reserves the right to deny any petition.
3. The Department of Public Works, Solid Waste Management Administration, Street and Alley Cleaning Division (SACD) will inspect the blocks, taking into consideration
a. the amount of litter,
b. the total number of residences, and
c. to determine the feasibility of mechanically sweeping.
4. SACD will verify all signatures. SACD will also inspect the blocks for proposed designated locations of poles and signs.
a. In cases where poles need to be installed Miss Utility will need to be notified. This may cause some delays in the process.
5. DPW/SWMA will notify the Advisory Neighborhood Commission (ANC) of a particular block requesting Street Sweeping and the approval of a petition. The ANC will be allowed an opportunity to advise the government on this issue as required by District of Columbia Law.
6. Upon a decision on the petition, SACD will notify the ANC and the citizen generating the petition of the determination.
a. If approved, the notification will indicate the date on which the NO PARKING FOR STREET CLEANING signs will be installed and the date sweeping will begin.
b. Department of Transportation (DDOT) will install the NO PARKING FOR STREET CLEANING signs.
